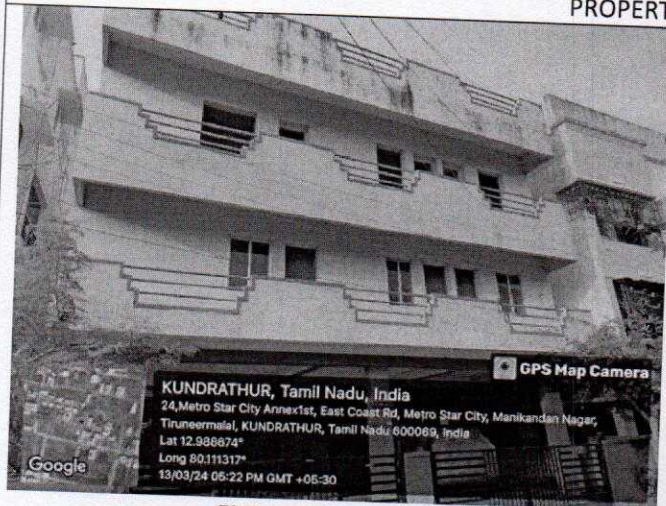

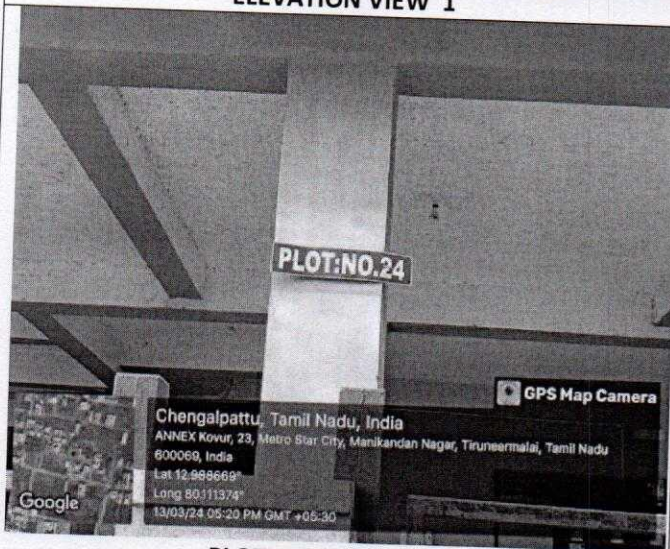

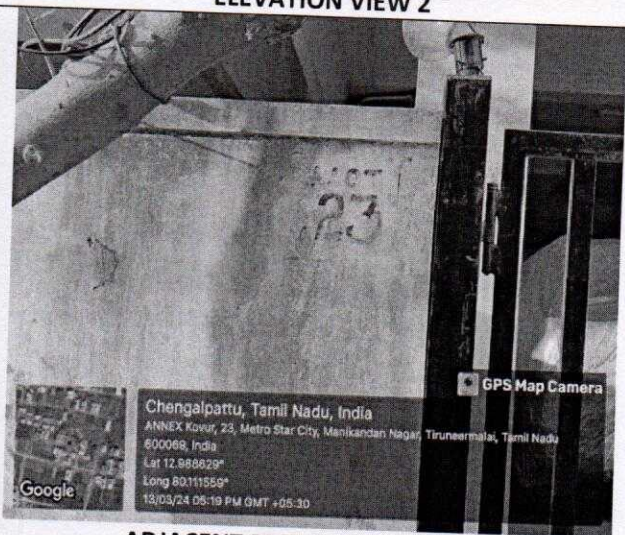
ELEVATION VIEW 1

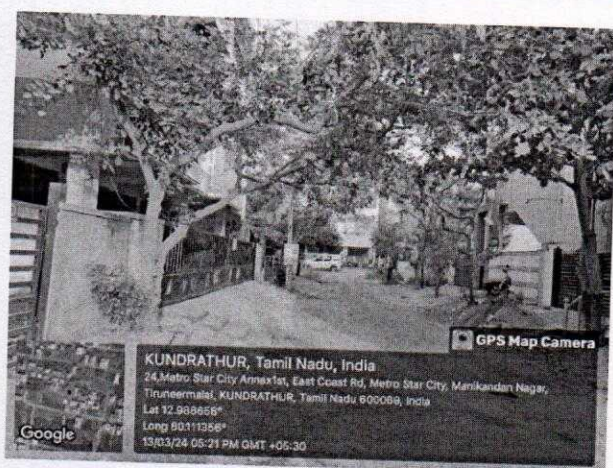
PLOT NUMBER VIEW

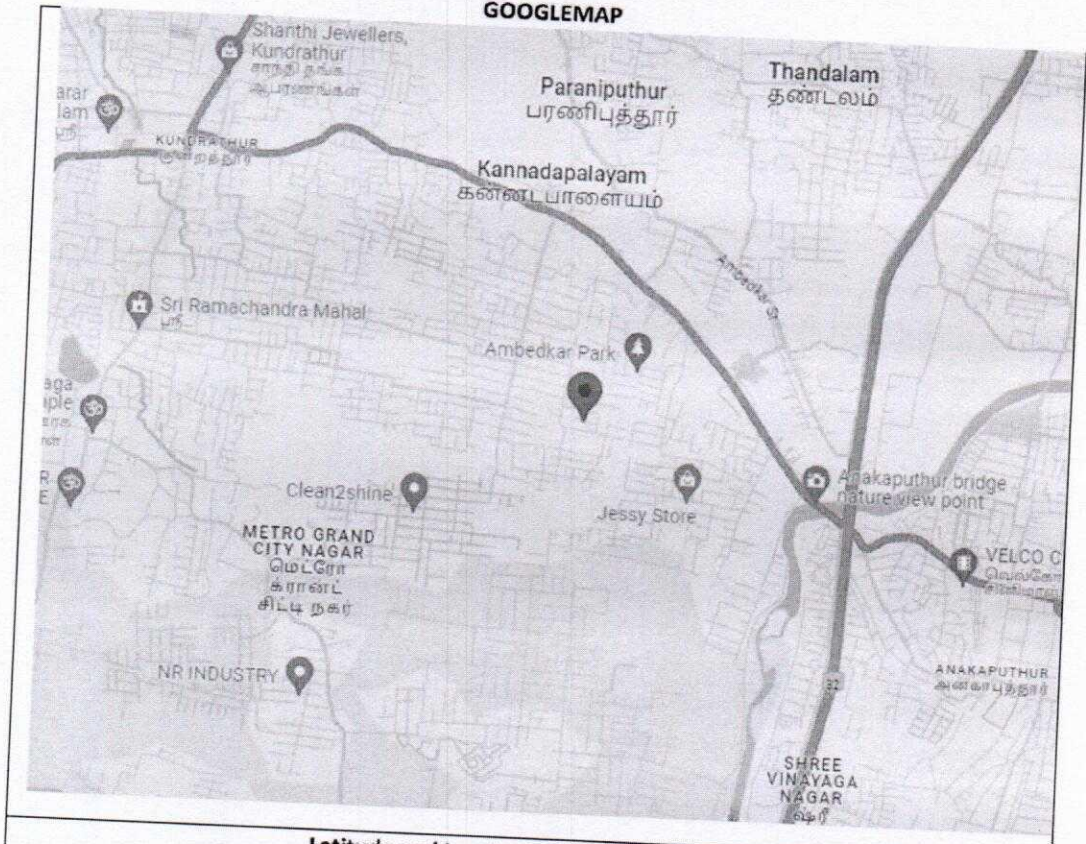


STREET NAME BOARD VIEW
